\*\*\* Please Note \*\*\* - Proof of liability insurance is required for all vehicles. When trailers are being towed, they are covered under your automobile insurance policy. Upon arrival, insurance typically switches to a homeowner's policy. The proof of insurance required to be on file is the liability policy that will cover the vehicle while at the fairgrounds. Insurance is available through California Fair Services Authority for \$10.00 and will cover from August 7-13, 2017. Insurance must be purchased with a cashier's check or money order only and made out to C.F.S.A.

## **2017 Fair Time Camping Rules**

- 1 CARNIVAL CAMPERS: No Parking behind trailers in grass area. No vehicles in the Fairgrounds from 10AM - 10PM each day.
- 2 LOWER CAMP & RACE CAMPERS: One vehicle allowed at camp spot with pass. Pass must be clearly displayed at all times. Parking must be within the chalked lines per Fire Marshall.
- 3 One parking pass will be issued per site.
- 4 Only one trailer per site
- 5 Campers may arrive beginning Saturday, August 5, 2017. CARNIVAL campers may not begin leaving until Sunday, August 13, 2017 at 5 pm.
- 6 Campers must sign out on Sunday with an official. One trailer will be moved at a time.
- 7 Think Safety 1st when setting up your trailer.
- 8 Any changes will be made by Fair Manager only and all decisions are final.
- 9 A parent, guardian or leader will be responsible for the activities at each camp site AT ALL TIMES. Junior Livestock exhibitors 18 and over WILL NOT be allowed to assume the role of responsible adult for the camp site.
- 10 Horse trailers must be parked in designated trailer areas and can not be parked at camp sites or in livestock area.

I have read the 2017 fair time camping rules, understand and agree to abide by them. I understand that violation of these rules could be cause for me to be removed from the fair camping program.
