Purposes of occupancy shall be limited to camping only. Renter agrees to pay to the Fair \$20.00 (Twenty Dollars) per day, per RV space or \$10.00 (Ten Dollars) per day for tent (dry) camping - no hook-up use.

Renter agrees to guarantee payment of the following:

- A) Any damage to Fair property
- B) Removal of renter's property if left behind, leaving the premises in a condition satisfactory to the Fair.

Renter agrees to indemnify and hold harmless the Fair and the County of Plumas, their officers, agents, servants and employees from any and all claims, causes of action and suits accruing or resulting from any damage, injury or loss to any person or persons, including all persons to whom the Renter may be liable under Workmen's Compensation law and Renter themselves and from any loss, damage, cause of action, claims or suits for damages, including but not limited to, loss of property, goods, wares or merchandise, caused by, arising out of, or in any way connected with the exercise by Renter of the privileges herein granted.

It is mutually agreed that this contract or the privileges granted herein, or any part thereof cannot be assigned or otherwise disposed of without the written consent of the Fair.

It is mutually understood that no alteration or variation of the terms of this contract shall be valid, unless made in writing and signed by the parties, hereto.

**Renter to furnish a copy of proof of insurance for any vehicles (trucks, trailers, campers, RV's) that will be present in conjunction with camping on Fair property.**

**Insurance must be on file with the Fair Office - PRIOR TO CAMPING / Insurance may be purchased through CFSA for \$10.00 and MUST BE PURCHASED WITH A MONEY ORDER OR CASHIERS CHECK.**
